Due to an extreme drop in orders in the business area of contract manufacturing of carbon parts for the automotive industry, combined with very poor prospects of being able to close the gaps created in the short and medium term, we unfortunately have to inform you that the company NEUFORM COMPOSITES GMBH & CO. KG ceased operation on January 31, 2020 and will subsequently be dissolved.
